Southeast Santa Rosa Meets Southwest!

Touring two diverse neighborhoods was the imaginative idea of Sonoma County Health Department and LandPaths to introduce *A Portrait of Sonoma County*, an in-depth look at how the residents of Sonoma County are faring in three fundamental areas: life expectancy, education, and income – all measures of the Human Development Index.

A group of neighbors from southeast and southwest Santa Rosa hiked the hills of East Bennett Valley and the flatlands of

2014 Fall Fund Drive "Over The Top"

Thanks to the generosity of almost 200 supporters, we surpassed our fundraising goal of \$30,000 by raising over \$39,000!

We want to recognize the Santa Rosa Cycling Club and the Empire Runners for making significant contributions that helped us exceed our goal. The eight individuals and 3 organizations that stepped forward to offer a \$7500 Challenge Grant deserve special thanks for their visionary leadership.

Much to our surprise, we received an anonymous gift of \$10,000 to start an acquisition fund for the Southeast Greenway. We are working with the Sonoma Land Trust to establish a dedicated fund for acquisition and are thrilled to launch this fund with this generous donation.



In addition to funding our annual operating costs, this year's fund drive was dedicated to helping meet the pre-acquisition costs that we anticipate in 2015. These include 2 professional appraisals required by Caltrans and paying for additional professional help that may be required as we work with Caltrans to establish a fair price for the property. Finally, we want to thank the many Greenway volunteers who helped with our annual mailing and phonathon. Their enthusiasm and dedication made it all happen!

Caltrans Visits Greenway Team

On February 12, two officials from the Caltrans District 4 Right of Way Department met with representatives of the Southeast Greenway Campaign and our community partners – the City of Santa Rosa, the Sonoma County Water Agency, and the Sonoma Land Trust. During the meeting we reviewed a proposed Memorandum of Understanding (MOU) that lays out



agreements for how we will work together to establish a value for the property, to negotiate a fair price, to gain the approval of elected officials and the California Transportation Commission and to transfer the property to the City and Water Agency. This was a very helpful and encouraging meeting. The City of Santa Rosa's Legal Department is currently reviewing the MOU. After the MOU is finalized, Caltrans, the Sonoma County Board of Supervisors, the Santa Rosa City Council, and the directors of each partner agency will need to approve it. Finalizing this key document is a big step forward on the road to acquiring the Greenway property.
